We hope and are working towards a means of publishing pictures of unusual pieces of Royal Bayreuth and also pictures of the convention for those members that are unable to attend.

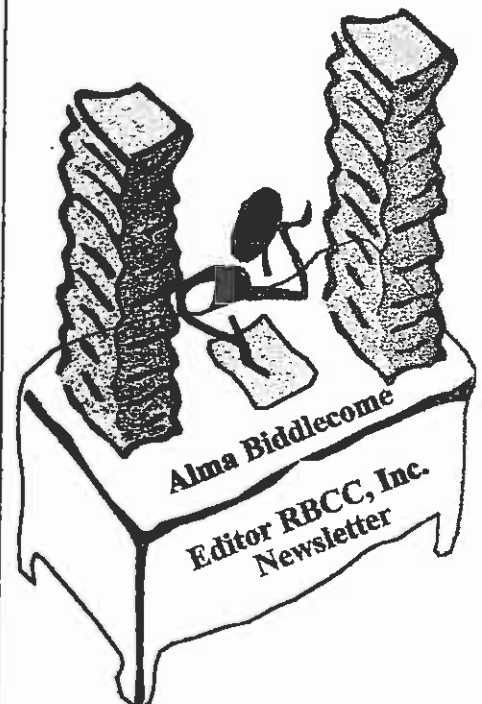
We must now start planning for our next convention in Syracuse, N.Y. which will be held on October 17, 18 and 19, 1997 at the Embassy Suites.

1996 Convention Highlights & Minutes

Welcome Meeting Oct. 18

President Jim Davis began the Welcome Meeting at 3:40 on Friday afternoon, October 18. He stated that the purpose of the meeting was not to do any club business, but only to help members get acquainted with each other.

The Executive Board members and officers were introduced.

New members than introduced themselves and talked a little about their particular collecting interests.

J. Davis read the Itinerary and explained the convention format and procedures to the new members.

A site for next year's convention was announced, the Embassy Suites at Syracuse, New York, from October 17th through October 19th. The new site allows the auction to be moved earlier in the meeting and a separate banquet room will be available for a possible program or entertainment.

Mary McCaslin was introduced; she announced that she had copies of her book available in her room.

Members who had attended the convention previously then introduced themselves and talked about their collection interests. Several told interesting stories of their ongoing search for Royal

Bayreuth, citing dealer comments such as "We don't carry that cheap stuff (of course this was said many years ago)" or "Royal Bay-what?" when asked about the availability of Royal Bayreuth.

The McCaslins talked about their trip for a month to New Zealand to visit Des and Cath Wicks and to research the Royal Bayreuth patterns and designs available there. They expressed great appreciation for the hospitality of the Wicks and other New Zealanders who welcomed them with vigor and opened their homes to show their Royal Bayreuth. The Stockwells told of their trip to the Royal Bayreuth factory in Tettau; they were also warmly received and were shown around the factory and showroom. Today's production is primarily dinnerware. Jim Davis told of visiting there in 1972 after the Salley Book was published. When Jim showed the Director the book, he said he had never seen the Corinthian pattern; Jim later sent him a piece for the museum there. Apparently, the factory did not keep sample pieces of china as they produced it and very little is now present in the museum display.

J. Davis read the Welcome Letter to the group, making final thanks to participants. The meeting was adjourned.

Executive Board Meeting Oct. 18

President Jim Davis called the meeting to order at 1:10 p.m. with Chuck and Sandy Heerhold, Richard Earle, Nancy Brandenburg, Bob McCaslin, Jim Davis, Jack Biddlecome, and Judy White present. Absent were Dee Hooks, Bob Mazza, and Bob Gollmar.

Jim Davis read a letter from Dee Hooks asking to be replaced on the Board due to the health problems of Maurice Hooks. The President will appoint a replacement. Dee Hooks will be missed on the Board.

President Davis had several pieces of business to announce:

He has filed Corporation papers in New York State, keeping the original papers in his file with copies to J. Biddlecome and J. White.

He has also filed the necessary paperwork to make the RBCC, Inc. a non-profit organization.

He has submitted the forms filled out by Jack Biddlecome, Treasurer and Judy White, Secretary, for bonding. The cost should be about \$90 per year per person. Discussion followed as to whether anyone else should be bonded, but it was decided that only these two positions handled the Club's money. Also discussed was whether a second person should be on the signature card for the

checking account in case the Treasurer was unavailable. J. Biddlecome will get the necessary paperwork to have the Secretary included.

A very important issue at this convention will be to get a replacement editor for the newsletter as C. Heerhold will no longer be editor. Chuck was thanked for his good job done on this year's paper, he in turn thanked his wife Sandy for all of her efforts. Volunteers will be asked for at the business meeting.

Several committees will be needed:

A nominating committee for next year to replace three members of the Board. The present Board and Officers should serve until 1998 convention according to the by-laws; thus, the nominating committee isn't really needed until next year to set up a slate for the 1999 fiscal year, at which time the officers and three Board members will be nominated.

An advertising committee to stimulate new membership is needed. Chuck Heerhold volunteered to take charge of that.

Discussion followed about the needs of membership; i.e., should there be a membership committee? Who is to produce the required membership brochure?

It was decided that no member-

ship committee is needed and Chuck Heerhold is to work on the brochure, along with the advertising. Clarification of membership policies should be a part of the brochure. Several points were discussed with these policies being clarified:

1. The membership year is from January 1 to December 31 of any year. There will be no prorating of dues but any NEW member joining from September 1 and on in any calendar year will be extended through the following calendar year. Any rejoining members must pay for each calendar year's membership. This policy resulted from a unanimous vote on a resolution made by C. Heerhold, seconded by Nancy Brandenburg.

2. Any member joining during the calendar year is entitled to all mailings and newsletters for the year. The Secretary should have available extra copies for this purpose.

3. A membership application form should be available in the last quarterly newsletter for renewals not paid at the convention. After the first of the year, the Secretary should mail reminders to those not yet renewed.

4. Richard Earle recommend that all membership dues be \$30 per year. C. Heerhold seconded the motion, which carried unanimously.

Bob McCaslin asked whether the election should be run by mail, but

since the by-laws state sections will continue to be held at the annual conventions.

Jack Biddlecome asked whether a voucher system should be used for all expenses. It was decided that a paper voucher must accompany all expense requests.

Because of additional expenses for meeting room rents for next year's convention in Syracuse, Jack Biddlecome asked whether the registration fee for that convention be higher than the previous \$10 per family fee. Discussion resulted in a consensus that these costs be assumed by the club.

Sandy Heerhold asked why the convention is held at this particular time of the year, as some members are not able to attend. The by-laws call for the convention to be held some time in September or October. Next year's dates are already set, but future plans can vary according to hotel availability.

J. White had asked that appointment of a Recording Secretary be considered because of the problem of the voting Secretary's being unable to participate fully in discussions while taking notes. It was decided to ask for a volunteer at the Welcome Meeting for a non-voting Recording Secretary. The meeting was adjourned at 3:10.

Executive Board Minutes Oct. 20

Jim Davis reminded board members that election of officers will take place at the October 1997 business meeting. Bob McCaslin made a motion, seconded by Chuck Heerhold, to appoint Mary McCaslin and Tim Gaudet to the Election Committee. The motion was approved. The terms of Bob Mazza, Paul Toland, and Dick Earle will expire in October 1997. Mary and Tim will seek nominees, and additional nominations will be accepted from the floor. The three incumbents will be given an opportunity to be placed on the ballot.

It was decided that Chuck Heerhold will take over responsibilities involved with the Club brochures and advertising. He has spoken to other members concerning new ideas. A motion was made by Bob Mazza and seconded by Paul Toland to set a ceiling of \$1,000.00 for advertising. The motion passed by a vote of 8:1 with one abstention.

It was also suggested that syndicated columnist, Anita Gold, be given an honorary membership to the RBCC, Inc. in exchange for printing articles about the Club and about Royal Bayreuth in general. She already has a similar agreement with the Toothpick Collectors group. A motion to contact Anita Gold with this offer was made by Bob McCaslin and seconded by Sandy Heerhold.

The motion was passed by a vote of 9:0 and one abstention.

Another suggestion to increase membership involved a rebate program to current members for recruiting new members. A discussion followed. Chuck Heerhold made a motion that would allow current members to deduct \$5.00 from the next year's dues for each new member recruited. The motion was seconded by Bob Mazza, and approved by a vote of 7:2 and one abstention.

Depending on the type of auction the Club hosts in years to come, Bob McCaslin made a motion: Beginning in 1997, the RBCC, Inc. may reimburse a professional auctioneer for up to two nights lodging. The motion was seconded by Chuck Heerhold and passed by a vote of 9:1.

A motion to adjourn was made by Chuck Heerhold and seconded by Dick Earle. The motion was unanimously passed.

RBCC, Inc. Minutes Oct. 19

President Jim Davis opened the meeting of the October RBCC at 9:15 a.m. He announced that the club has been incorporated with non-profit status. A \$150.00 filing fee was paid to the IRS for exemption as a non-profit organization.

The Club also filed with an insurance company to bond our secretary and treasurer for \$10,000 each. The yearly premium for both is \$90.00. The Club's books have also been audited. One expenditure that the board approved after last October's meeting was replacement and payment of ads to attract new members.

Jack Biddlecome, Treasurer, reported that October 18, 1996 audit indicated a balance prior to the convention of \$4,446.08. Approximately \$2,000.00 will be subtracted for convention expenses. Des Wicks congratulated Jack on the complete and accurate work he has done with the Club's books.

Records from Judy White, Secretary, showed that there were 35 charter memberships and 54 total members at the end of the 1995 RBCC convention. As of October 18, 1996 there are now 104 memberships and 176 total members. Judy also received a note from Evelyn Schaefer, a charter member, expressing regret at not being able to attend this convention due to a family illness.

Under New Business, Jim Davis reported that the Heerholds had volunteered to be newsletter editors for one year, and that the position of editor is now open. Jim called for volunteers, explaining that the job involves a time commitment and probably a

computer. The Biddlecomes volunteered to take over as editors and were unanimously applauded in for the job. Jim asked members to provide articles and input for the quarterly newsletters to Alma and Jack Biddlecome.

In other new business, Dee Hooks had to step down from her position on the executive board due to her husband's illness. Paul Toland will take her place until her term expires.

In the Executive Board meeting, it was decided that Chuck Heerhold will take care of advertising with the primary focus on recruiting new members. Judy White will design and print an RBCC, Inc. brochure containing information on the club's goals, purpose, reasons for joining, and membership application. The brochures will be distributed to members to place at antique shows and give to friends and dealers. After a discussion as to where to place paid ads and how much money to budget for advertising, it was felt by a consensus of the membership present that ads placed in the *Antique Trader* would be the most productive. A motion was made by Jack Biddlecome and seconded by Dottie Earle to submit a membership ad every three months to the *Trader*. The motion passed. In addition, a new release will be sent to major

antique newspapers and journals with coverage of the 1996 RBCC, Inc. convention.

At the Executive Board meeting, it was decided to keep membership dues at \$30.00 per year. Dues will cover the period from January 1 through December 31. If a member joins between September 1 and December 31, the dues will cover that period plus the next 12 months of the following year. Members joining prior to September 1 will receive a copy of any newsletters sent out during the membership period, including back issues. This announcement will appear in the next newsletter. Membership dues should be paid at the convention or sent to Jack Biddlecome or Judy White.

Jim Davis reported that the auction committee is in need of additional pieces for Sunday's auction. Larry Brenner suggested that the auction should be held on Friday or Saturday since several members were unable to stay for a Sunday auction. Jim responded that next year's auction will be held on Friday. Larry then made a motion to move this year's auction to today so that all members would be able to attend. The motion was seconded, and a discussion followed. The motion was defeated.

Chuck Heerhold then made a

motion to waive the rule limiting the number of pieces a member is allowed to put in the auction. The motion was seconded and passed. Chuck's second motion was to waive the rule excluding pieces that have been shown in rooms. The motion was amended to cover this convention only. This motion was seconded and passed. Chuck also asked if reserves on individual pieces are confidential. According to RBCC, Inc. By-Laws, all reserve bids are confidential.

Jim Davis asked members to put better pieces in the auction. He explained that 8% of the selling prices goes to the Club. If an item is unsold, the owner donates \$10.00 to the Club. Mary McCaslin suggested that we consider having a donation auction where all profits go to the Club.

Bob McCaslin asked what type of auction members would like to see at future conventions. A lengthy discussion outlining pros and cons ensued. Following a recess caused by a fire alarm at the hotel, the membership voted informally on the possible types of auctions. The options and votes recorded:

1. Member consigned pieces only; a member or volunteer auctioneer. 18 votes.

2. Professional auctioneer brings in private collection; auction is open to the public; auctioneer makes donation to the Club:

13 votes

3. Consignment auction with professional auctioneer, may include member-consigned pieces and outside pieces; Club will provide lodging if all pieces are consigned; 8% of sales goes to the Club: 13 Votes.

Paul Toland, chairman of the auction committee, will take this informal tally under advisement in planning for next year's convention.

A reservation fee has already been paid on the Embassy Suites in Syracuse, New York, the site of the 1997 RBCC, Inc. Convention. Bob Mazza, Dottie and Richard Earle, and Judy and Ken Stockwell will host the hospitality room. Members are encouraged to bring cookies and other snacks. Judy White will send get-well and thank-you cards to Mr. and Mrs. Bob Gollmar. Mrs. Gollmar recently had surgery, but Bob took time to make several trips to Schaumburg to help with the auction and hospitality room. Jim Davis would also appreciate hearing from members willing to put on programs for next year's convention.

Convention plans for 1998 are already under way. St. Louis is the probable site, although Las

Vegas was suggested.

Jim Davis announced that the two programs for this afternoon will be held at 1:00 and 2:15. Harriet Land and Des Wicks are this year's presenters. A motion to adjourn the meeting was made and seconded, and the motion passed at 11:0.

the auction;

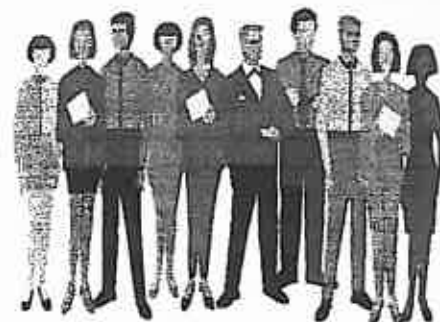
Harriet Land and Des Wicks - for two excellent programs and slide presentations.

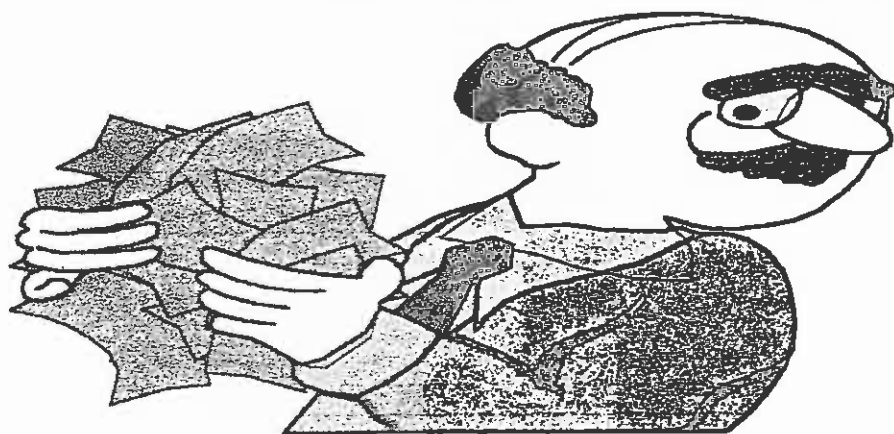
